

Gift of Publicly Traded Shares to Georgian Bay Symphony

Thank you for supporting the Georgian Bay Symphony with a gift of securities. Transferring securities (stocks, bonds, mutual funds) is simple, and may result in significant tax saving to you.

To transfer securities, please follow the steps below:

- 1. Complete the form below and send it to your broker or financial advisor. Your broker will arrange the transfer of shares to the Georgian Bay Symphony investment account. The Georgian Bay Symphony cannot initiate the transfer.
- 2. Once the form is complete, your broker should send a copy to RBC Direct Investing Inc.
- 3. Upon receipt of the transferred securities in the Georgian Bay Symphony's brokerage account, RBC Direct Investing Inc. will advise us of receipt of the securities and the closing bid price on the day the securities are received in our account.
- 4. For donation receipt purposes, the value of the shares will be determined by closing bid price at close of business the day the shares are received in the Georgian Bay Symphony's account. The donation receipt will be issued to you for fair market value of the shares as determined by the closing bid price.
